


Participation of the Institute for African Studies of the Russian Academy of Sciences in the events of the XIV RISA Convention

The event was organized by the Centre for History and Cultural Anthropology and the Centre for Southern Africa Studies. The conference marked the 120th anniversary of the end of the first major armed conflict of the twentieth century. The event is dedicated to the memory of Dr

Gennady Shubin (1966–2016), a research fellow at the Institute for African Studies and leading expert in the study of the Russian involvement in the Boer War. Read more

Scientific Conference With International Participation "Liberia Yesterday and Today: 200 Years of Independent Development"

On November 16, 2022, a scientific conference was held at the Institute for African Studies of the Russian Academy of Sciences on the topic "Liberia yesterday and today: 200 years of independent development". The choice of the subject of discussion, as can be seen from the name of the forum, was because in 2022 this West African state celebrated 200 years since the appearance in 1822 on its current territory of the first settlements created by freed from slavery American blacks who arrived in West Africa from the USA and in 1847 founded the independent Republic of Liberia. The country turned out to be one of two (the second is Ethiopia) on the African continent that did not have a colonial past. Read more

Expedition of IAfr RAS faculty to the United Republic of Tanzania

From 09/19/22 to 10/09/22, faculty of the Center for History and Cultural Anthropology Anastasia Banshchikova, Valentina Bryndina, and Oxana Ivanchenko conducted an expedition that became the final stage of the study conducted in the United Republic of Tanzania, dedicated to the memories and ideas of Tanzanians about the Arab-Swahili slave trade of the 19th century. The geography of the study was expanded, this time the expedition members visited the main trading city of the 19th century, located in the middle of the central caravan route, Tabora. In addition, research was continued in Zanzibar, as in

the course of previous seasons it turned out that there is a significant difference in the answers of native Zanzibaris and those who came there to live/work in the first generation. As a result, 25 interviews were collected, 13 of which were in Swahili. Read more

Another military coup in Burkina Faso

Within one year, two military coups took place in Burkina Faso: on January 24 and September 30, 2022. This was the eighth in a row since the country gained independence in 1960. On September 30, detachments under the command of Captain Ibrahim Traore entered the capital Ouagadougou and, after a series of clashes with government troops, defeated them. The roads leading to the palace of the President, Lieutenant-Colonel Paul-Henri Damiba, were blocked, and television broadcasting was stopped. Read more




Khairullin T.R. "Modern Islamism in the Arab World".


The monograph analyzes the historical background and causes of the expansion of domestic, transborder, and international migration flows in Africa in the early 21st century.
